• Most lenders and landlords offer temporary payment deferrals or forbearance plans during federal shutdowns. Contact them directly and provide proof of furlough or employment impact. Property managers are encouraged to offer grace periods and flexible payment plans. Our office can help connect tenants with available resources, clarify housing-related guidance, and elevate urgent cases to the appropriate agencies when needed. Federally Subsidized Housing: Section 8 and HUD-VASH vouchers remain active. Tenants must still pay their portion of rent. No automatic eviction pause—tenants should request flexibility from landlords.

Emergency Rental Assistance Program (ERA)

- Covers rent, arrears, and utility bills for eligible renters affected by income loss. Payments are generally made directly to landlords or utility providers.

Employment Status: Furloughs are temporary suspensions due to funding lapses, not terminations. If you're unsure about your status, we can help interpret your agency's notice.
